#### MINUTES OF THE BOARD OF SUPERVISORS MEETING OF HOBE-ST. LUCIE CONSERVANCY DISTRICT JUNE 28, 2023

Pursuant to the above Notice, the Board of Supervisors of Hobe-St. Lucie Conservancy District held its Board of Supervisors Meeting on June 28, 2023 at 9:30 A.M. at the Hobe Sound Polo Club located at 2935 SE Bridge Road, Hobe Sound, Florida 33455.

Present were Rick Melchiori, Edward Weinberg and Robert Brown, Supervisors; Michael McElligott of Special District Services, Inc. as District Manager; Robert Higgins of Higgins Engineering, Inc. as District Engineer; and Mary M. Viator, Attorney and Secretary. Also in attendance was Mr. Paul Whalen, Mr. Ray Spears of The Grassroots Corp. and Mr. Jacques Mouracadeh of Coventry Development via telephone.

#### CALL TO ORDER

The Board of Supervisors Meeting was called to order by President Melchiori.

#### ESTABLISHMENT OF QUORUM

The President announced a quorum was present and it was in order to transact any business to come before the Board.

#### ADMINISTER OATH OF OFFICE

The Oath of Office was administered to Mr. Melchiori who took his seat on the Board.

#### **0ELECTION OF OFFICERS**

The District Manager announced it was in order to elect Officers. Thereupon, the following slate of Officers was presented:

A motion was made by Mr. Weinberg, seconded by Mr. Brown and unanimously passed approving the election of Officers as presented.

#### ADDITIONS OR DELETIONS TO AGENDA

#### COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

None.

#### APPROVAL OF MINUTES

A motion was made by Mr. Brown, seconded by Mr. Weinberg and unanimously passed approving the Minutes of the June 7, 2023 Board of Supervisors Board Meeting.

#### OLD BUSINESS

1. <u>Update Regarding RG Reserve Pipe Permit Application</u>

The District Engineer indicated he had been contracted by the Consultant of RG Reserve who was putting together a plan for the Engineers review. The Consultant acknowledged the need for the Outfall and indicated the need to pay for the District's review and the adverse effects.

2. Update Regarding Howe Holdings Agreement

The District Engineer commented on Howe Holdings.

The District Engineer explained that Howe Holdings, had signed the Irrigation Agreement but had not provided the original executed agreement.

The District Engineer indicated he had inquired as to the status of payment and the original executed agreement.

#### 3. <u>Status Update Regarding South Florida Water Management District Assessments:</u>

The District Administration presented the breakdown regarding SFWMD Delinquent Assessments set forth on Exhibit "A" which included the following:

- a. SFWMD as Primary and/or Sole Owners in Hobe-St. Lucie Conservancy District.
- b. Tax Collector Distribution Received
- c. Late Fee ("Loan") Change. The Total Late Fee Charge is \$282,209.34
- d. Projected Disbursements to Funds

The information was discussed with the Board. The District Manager explained the distribution of the additional funds received from the carrying costs.

The Unit 5 Funds would be applied to the Unit assessments.

A Motion was made by Mr. Brown, seconded by Mr. Weinberg and unanimously passed to accept the presented Distribution of SFWMD Delinquent Funds and adjust Unit 5 assessments to zero for the 2023-2024 Fiscal Year.

There followed Board discussion as to the payment of the outstanding District delinquent assessments. The District Manager reported that SFWMD had paid all of the past outstanding assessments. Martin County had paid the three (3) past year assessments but had not paid for the prior past due years in the amount of \$6000.00.

The Board directed the District Manager to prepare a letter to Martin County notifying

Martin County of their failure to pay their outstanding assessments to HSLCD.

#### 4. Discussions Regarding SFWMD Access Permit for Geotech

The District Manager explained SFWMD had requested an Access Permit for Geotech. The Board had reviewed the requested back up information as to the specific locations of the Access Permit and the services to be performed within the Access Permit. The Board directed the Permit be limited to the District's easements (not the ROW's). The Board requested further explanation by Senior Management at SFWMD.

The District Engineer presented the Proposed Second Amended Water Control Plan for Unit of Development No. 1A. He explained the Amendment included the Operation Schedule for Unit 1A which was used for the Grove.

#### RESOLUTION DESIGNATING HOBE-ST. LUCIE CONSERVANCY DISTRICT UNIT OF DEVELOPMENT NO. 6

WHEREAS, the Board of Supervisors of Hobe-St. Lucie Conservancy District designates the real property described in attached Exhibit "A" (the "Real Property") as a Unit of Development pursuant to the provisions of Chapter 2005-339, Laws of Florida, as amended and/or supplemental (together the "Act"); and

WHEREAS, the Real Property lies within the jurisdictional boundaries of Hobe-St. Lucie Conservancy District; and

WHEREAS, the Board of Supervisors of Hobe-St. Lucie Conservancy District finds that the Real Property is suitable for designation as a Unit of Development over which the District may exercise some or all of those powers granted to it pursuant to the Act and applicable provisions of Chapter 298, Florida Statutes.

**NOW, THEREFORE**, BE IT RESOLVED by the Board of Supervisors of Hobe-St. Lucie Conservancy District as follows:

1. The Real Property described in attached Exhibit "A" is hereby designated as "Hobe-St. Lucie Conservancy District, Unit of Development No. 6 for the purpose of Hobe-St. Lucie's exercise of some or all of those powers granted to it under and pursuant to the Act and applicable provisions of Chapter 298, Florida Statutes, for the benefit of the Real Property and this Unit of Development.

2. That the location, area and boundaries of the Unit of Development No. 6 shall be as described in attached Exhibit "A".

- 3. That all resolutions or parts of resolutions in conflict herewith are hereby repealed.
- 4. This Resolution shall take effect immediately upon its adoption.


