MINUTES OF THE BOARD OF SUPERVISORS MEETING OF HOBE-ST. LUCIE CONSERVANCY DISTRICT October 24, 2024

Pursuant to the above Notice, the Board of Supervisors of Hobe-St. Lucie Conservancy District held its Board of Supervisors Meeting on October 24, 2024 at 9:30 A.M. at the Becker Tree Farm & Nursery located at 2400 SE Bridge Road, Hobe Sound, Florida 33455.

Present were Rick Melchiori, Edward Weinberg and Robert Brown, Supervisors; Michael McElligott of Special District Services, Inc. as District Manager; Patick Helms of Higgins Engineering, Inc. as District Engineer; and Mary M. Viator, Attorney. Also in attendance was Frances M. Bethel, Attorney, and Mr. Ray Spears of The Grassroots Corp.

A. CALL TO ORDER

The Board of Supervisors Meeting was called to order by President Melchiori.

B. PROOF OF PUBLICATION

C. ESTABLISHMENT OF QUORUM

The President announced a quorum was present and it was in order to transact any business to come before the Board.

D. ADDITIONS OR DELETIONS TO AGENDA

The District Manager informed the Board that Item 4 under New Business, "Consider Approval of Disbursement #2," would be discussed at this Meeting, but no action would be taken at this time.

F. <u>APPROVAL OF MINUTES</u>

A motion was made by Mr. Brown, seconded by Mr. Weinberg and unanimously passed approving the Minutes of the July 24, 2024 Board of Supervisors Board Meeting.

G. OLD BUSINESS

1. <u>Status Regarding RG Reserve</u>

The Board discussed the SFWMD permit.

The Board directed discussion of these matters be deferred. No action would be taken at this Meeting.

2. <u>Update Regarding Access to Elise J. Property:</u>

The District Attorney provided a Memorandum to the Board relating to the District's ownership of lands in the area of the entrance to the Trailside Subdivision. According to the Property Appraiser's records, the District owns a contiguous strip of land from an area west of the Trailside entrance extending eastward to Seminole Pratt Whitney Roads and beyond. The lands are utilized as the Hobe St. Lucie Irrigation Canal.

Following discussion by the Board, the Board agreed action would be deferred at this time.

3. <u>Update Regarding Sandglass Golf Range House Location</u>

The Board directed discussions of these matters be deferred and no action would be taken at this time.

H. <u>NEW BUSINESS</u>

Acceptance of Quit Claim Deed From Discovery Hobe Sound Investor, LLC to Hobe Sound Conservancy District

A Motion was made by Mr. Brown, seconded by Mr. Weinberg, and unanimously passed accepting the Quit Claim Deed from Discovery Hobe Sound Investor, LLC to Hobe Sound Conservancy District.

3. Consider Resolution No. 2024-11 – Adopting Goals and Objectives:

4. Consider Approval of Disbursement #2

The Attorney explained for Phase 2, the identification of the remaining Improvements to be transferred to the District and the purchase price thereof will be determined in the future by a separate Acquisition Agreement. The Phase 2 Transfer will include the remaining components of the Discovery PUD SWMS and any remaining Improvements required to be transferred to the District by Unit 1A Amended and Restated Water Control Plan. These Improvements will be described in greater detail and certified by the District Engineer to be "functional, complete and operational" in the same manner as Phase 1 Improvements. The purchase price for Phase 2 will be as certified by the District Engineer, but payment for the Phase 2 Improvements will not exceed the amount of the District's undisbursed and legally available Series 2024 Bond proceeds.

The Board discussed Disbursement #2 and deferred action on this matter until a later time.
